Normal cut off date for transfer & rotation, as per transfer policy 2015-16, is 30th June of every year. Hence officers due for transfer in the month of July, August & September shall be considered in AGT 2018 and the officers due for transfer in the month of October onwards shall be considered in the AGT of next year.
