The above promoted officers should join on or before 27.09.2016 in the Chief Commissioner's Office, Central Excise & Service Tax Nagpur Zone, Nagpur from where the Commissionerate would be allocated to them subsequently. If any officers fails to join by the said date, it will be treated as if he/she has refused the promotion & accordingly the promotion order will be cancelled and he/she will not be offered any promotion as per Para 3 of MHA Department of Personnel and Administrative Reforms, New Delhi's O. M. No. 22034/3/81-Estt(D) dated 01.10.1981 & OM No. 16/7/90-Estt.(Pay-I) dated 09.09.1992 & 20.3.1995 for a period of one year or till the next vacancy arises, whichever is later.
3. Under the provisions of FR(22)(1)(a)(I) the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising their option shall be entertained.
4. The officers who have already been given the benefit of 1<sup>st</sup> / 2<sup>nd</sup> or 3<sup>rd</sup> financial up gradation under ACP/ MACP Scheme will not be entitled for the pay fixation benefit.
5. The above promotion is subject to the outcome of O. A. NO. 960/2011 filled by Sanjay Pathak V/s. Union of India pending with the Hon'ble Central Administrative Tribunal, Jabalpur, and other similarly placed cases .
