PUBLIC NOTICE No. - 01/2018-CUS

SUBJECT: - Appointment of Custodian of Import and Export goods under Section 45(1) of the Customs Act, 1962 -Regarding

Vide Public Notice No. 02/2016-Cus dated 05.04.2016 issued under C.No. VIII(CUS)25-69/2009/CT/1995 to 2003 and in exercise of powers conferred under Section 45(1) of the Customs Act, 1962, M/s Distribution Logistics Infrastructure Pvt. Ltd., Integrated Logistics Park, ICD, Borkhedi, Nagpur - 441108 had been appointed as "Custodian" of imported goods received in Inland Container Depot, Borkhedi until they are cleared for home consumption or warehoused or transhipped in accordance with the provision of the Chapter VII of the Act, ibid and also for the goods intended for export till their actual exportation at the port of exit. This Custodianship was valid for 2 (two) years from 05.04.2016.

- In exercise of the powers conferred under Regulation 10(2) of Handling of Cargo in Customs Areas Regulations, 2009, the Custodianship is extended for a period of 5 (five) years from today i.e.
- 3 This extension is subject to the satisfaction of the Commissioner of Customs, Nagpur who shall also have the right to terminate the said appointment at any time after assigning specific reasons for the breach of any of the provisions of the Customs Act, 1962 relating to such activity as permitted under this Public, Notice and or any other Public Notices in this behalf by giving them an opportunity to explain their case.
