PUBLIC NOTICE NO. - 24/2017-CUS

All the Customs Brokers of this Commissionerate are hereby informed that an oral examination for G-Card is being conducted in this Commissionerate on 21/12/2017 at Conference Room - 215, GST Bhawan, Civil Lines, Telangkhedi Road, Nagpur – 440001 at 11:00 A.M. for the candidates who had appeared in written examination under Regulation 17(3) of CBLR, 2013 as per Public Notice no 04/2017 dated 02/02/2017 and subsequently have passed in the written examination as per Public Notice No. 19/2017-CUS dated 12/10/2017, as well as for the candidates those who have passed in written examination on earlier occasion but failed in oral examination and who have not exhausted their admissible attempts as per Regulation 17(3) of CBLR, 2013.

- 2) The Roll Number for the oral examination shall remain the same in respect of candidates appearing immediately after 2017 the written examination. All the candidates appearing in the oral examination are required to bring their original Admit card of Written Examination on the day of oral examination.
- The candidates who have passed written examination at earlier occasion are also eligible for oral examination on separate registration with Customs Technical Branch, Nagpur-I Commissionerate on or before 11/12/2017 along with copy of result and undertaking mentioning the number of attempts made in earlier written and oral examination. Such candidates shall be issued separate Roll Number.
- 4) All the candidates are advised to report atleast an hour before the scheduled time, along with all the original documents of which copy was submitted at the time of application and one set of said documents may be kept ready for submission at the time of oral examination.
- 5) The candidates who had passed both written as well as oral part of the examination will only be considered eligible to apply for G-Card. It must also be noted that mere appearing in the written and oral examination does not confirm the right of getting of G card.
