In continuation of this office Public Notice No. 4/2017 dated 02-02-2017, all the Customs Brokers and Authorised Couriers licensed/registered at Nagpur Customs are hereby informed that Category 'G' written examination under Regulation 17(3) of the Customs Broker Licensing Regulation, 2013 is scheduled to be held from 10-00 hrs to 13-hrs on 20th April 2017 at Room No. 212, Second Floor, Office of the Principal Commissioner, Customs ,Central Excise and Service Tax , Telangkhedi Road, Nagpur-I Commssionerate.

2. Category 'G' examination shall include a written and an oral examination. The written examination will be of 100 marks and the minimum qualifying marks will be 50 marks in the examination. An applicant will be declared to have passed in the written examination only when he/she secures minimum 50 marks in written examination. As per rules each applicant would be permitted to avail of maximum of four chances/attempts to qualify in the written and oral examination from the date of his/her first appearance/date of appointment with the present Customs Broker/Authorised Courier whichever is earlier. It is also informed that those applicants who have failed to qualify in the last three written examinations must ensure that, if they appear, they will have to qualify in the ensuing examination failing which they will not be allowed to appear in next Category 'G' examination.

The list of eligible candidates for the G card written examination is enclosed with this Notice as Annexure A. The written examination shall be followed by an oral examination only for candidates who are qualified in the present written examination or in the past written examinations and have attempts left. This shall be notified at a later date.

Example: A person who qualifies in the written examination in the first chance/attempt but fails to qualify in the oral exam linked to the corresponding written examination, will get another three chances/attempts for oral examination, If a person qualifies only in his fourth (last) chance/attempt in the written examination, he will get only one chance for oral examination linked to the written examination.

- All the eligible candidates shall collect their admit cards from Customs Technical Branch, Nagpur-I Commissionerate between 3rd April, 2017 to 7th April, 2017. At the time of collecting admit cards, candidates are required to bring their original Aadhar card for verification (or original driving license or original PAN card if Aadhar card in not available.) and two passport size photographs.
- 4. Candidates should produce the admit card in original along with a valid photo ID on the day of examination failing which they shall be not allowed to appear in the said examination. Mobile phones, bags etc., are strictly not allowed in the examination hall. Candidates found to be indulging in any sort of unfair means during the examination shall be debarred from appearing in the said examination for their lifetime and their 'H' card shall be revoked immediately
