The Customs Broker and their employees are hereby informed that a Written Test for Category 'G' Examination under Regulation 17(3) of CBLR, 2013, is scheduled to be held in the month of March, 2017. The applications in the prescribed format, as appended to this notice, is invited from all eligible candidates holding 'H' Category Customs Passes issued under CBLR, 2013. The eligible candidates may apply along with the copies of documents as indicated below, duly attested by a Gazetted Officer, in the Custom Technical Section, Nagpur-I Commissionerate on or before 28th Feb, 2017 :-

- I) Copy of Category ' H ' Photo identity pass and copy of appointment order by present CB and date from which employed.
- II) Copies of Certificates of Educational Qualifications i.e. Certificate of passing 10+2 or equivalent examination recognized by the Government.
- III) Proof of Residence as evident from any document issued by Central or State Government.
- IV) If there is any change in name, Gazette Notification/ Marriage Certificate in support of such change.

NOTE:

- 1) The actual date, time and venue of the examination shall be announced in due course.
- 2) The candidates may note that in case any information given in the application is found incorrect or any document submitted is found forged or fabricated, such candidate will be debarred from appearing for any examination under CBLR, 2013 and/or from holding any Customs pass. Such candidates may also be liable for action under any law for the time being in force.
- 3) Application will be received in the Custom Technical Section of Nagpur I Commissionerate on all working days during office hours from 6/02/2017 to 28/02/2017. Incomplete application and application not accompanied with prescribed documents will not be accepted.
