Subject:-Withdrawal of Government appeal under Instruction F. No. 390/Misc./163/2010-JC dated 17.12.2015 issued by Central Board of Excise and Customs, New Delhi -Reg.

In order to reduce the Government litigation, the Central Board of Excise and Customs, New Delhi has fixed the monetary limit of Rs. 10 lakhs, for the appeal before Hon'ble CESTAT and Rs. 15 lakhs for the appeal before Hon'ble High Court, below which appeal should not be filed by the Department. Instruction F. No. 390/Misc./163/2010-JC dated 17.12.2015 has been issued in this regard. Further, this enhanced monetary limit shall apply to all pending departmental appeals as clarified vide Instruction F. No. 390/Misc./163/2010-JC dated 01.01.2016. Accordingly applications for withdrawal of appeals before Hon'ble CESTAT and Hon'ble High Court have been filed by this office.
