This office has initiated a process of appointment of two Special Public Prosecutors (SPP's) for handling cases Criminal/Prosecution before the Subordinate Courts/Courts Session, Nagpur/Bhandara and High Courts at Nagpur for Nagpur-I / Nagpur-II Commissionerates in terms of Instructions/Guidelines issued by the Government of India, Ministry of Finance, Department of Revenue, Central Board of Excise & Customs, New Delhi vide F. 278A/54/2015-Legal dated 29.02.2016 read with F. 278A/82/2008-Legal dated 25.05.2010. All the aspiring advocates who have been practicing as an advocate for not less than 10 years & also qualify in terms of Section 24(8) of the Criminal Procedure Code, 1973 to the Bar Council of the High Court of Nagpur/ bar Associations of Subordinate courts of Nagpur, Bhandara are requested to submit their application in Proforma 'A' alongwith all relevant documents to the undersigned on or before 16.03.2017. The advocates desiring to apply for selection of more than one Subordinate Courts/Courts of Session, as mentioned above, needs to apply separately for each of such place.

The first engagement of an SPP shall normally be for a period of 18 months. Such engagement will be renewable on receipt of recommendation of the concerned Chief Commissioner alongwith the annual performance appraisal on completion of first 12 months of the engagement.
