PUBLIC NOTICE

This office has initiated the process of appointment of Special Public Prosecutors (SPPs) for handling cases of Criminal/Prosecution before the High Court of Nagpur and Subordinate Courts/Courts of Session falling under the jurisdiction of the CGST Commissionerates of Nagpur-I, Nagpur-II and Customs Commissionerate, Nagpur in term of Instructions/ Guidelines issued by the Government of India, Ministry of Finance, Department of Revenue, Central Board of Excise and Customs, New Delhi vide F.No. 278A/54/2015-Legal, dated 29.02.2016. All the aspiring advocates who qualify in terms of Section 24(8) of the Criminal Procedure Code, 1973 to the Bar Council of the High Court of Nagpur/ bar association of Subordinate Court falling under the jurisdiction of the CGST Commissionerates of Nagpur-I, Nagpur-II and Customs Commissionerate, Nagpur can apply.

The applicants should apply along with the Bio-data in Proforma 'A' along with all relevant documents and willingness to the Principal Commissioner of CGST & Central Excise, Nagpur-I so as to reach on or before 15.10.2021. The advocate desiring to apply for selection for more than one subordinate courts/Courts of Session, as mentioned above, needs to mention the same in their application.

The first engagement of an SPP shall normally be for a period of 18 months. Such engagement will be renewable on the basis of recommendation of the concerned Chief Commissioner on completion of the first 12 months of engagement.
