1. This is for information to all concerned that as per Annexure-I (Copy enclosed) old furniture/articles will be sold on 11.10.2017 by calling tender/bill. In this regard Tender/Bids will be opened at 03.00 pm. on 11.10.2017 in conference hall of office of the Principal Commissioner, GST, Nagpur-I, Telangkhedi Road, Civil Lines, Nagpur. The highest bidder will be awarded the bid materials. The bidders are welcome to come and witness the opening of tender/bids.
2. The materials can be inspected at site at Ground Floor and 4<sup>th</sup> Floor, Office of the Principal Commissioner, GST, Nagpur-I, Telangkhedi Road, Civil Lines, Nagpur. The material are offered for sale on "As is where is bases".
3. The bidder will have to deposit Bank Draft of Rs.5,000/- (returnable) amount immediately. The payment should be made in form of Bank Draft Drawn on any Nationalized Bank the Pay & Account Officer, Customs, Central Excise, Nagpur-I The bidders whose bid is accepted, has to deposit the remaining amount in form of Demand Draft within 3 days of successful of the bid in favour of the Pay & Accounts Officer, Customs & Central Excise, Nagpur-I.

No processing before removal from owner premises will be permitted.

## **ANNEXURE – I**

### General terms & conditions for sale of scrap/unserviceable materials

The bidder is requested to be through the following conditions and submit the same with the tender signing each page in token of having gone through the conditions and his acceptance of the same.

1. (A) The bidder whose bid is accepted will have to deposit 25% amount of the accepted amount immediately in the form of Bank Draft Drawn on any Nationalized Bank payable at the Pay & Accounts Officer, Customs & Central Excise, Nagpur and the remaining amount within seven days of the approval of the bid. If the bidder and materials and the amount of deposit paid by him would stand forfeited.

(B) The material can be inspected at any working days (except Saturday/Sunday & closed holiday) from 03.00 pm to 05.00 pm from 05.10.2017 & 06.10.2017. The bidder are requested to meet Shri R.D. Tekam, Superintendent, Customs & Central Excise, Nagpur-I, Telengkhedi Road, Civil Line, Nagpur-I, Commissionerate (Mob. No.7030128060) before any such inspection so that they will be given the permission to go into the office before for inspection of the materials etc. the materials are offered for sale on "As is where is basis".

2. (A) Release order for delivery of materials shall be made only after receipt of the full bid price of the materials. The payment should be made in form of Bank Draft Drawn on any Nationalized Bank payable at the Pay & Account Officer, Customs & Central Excise, Nagpur-I.
