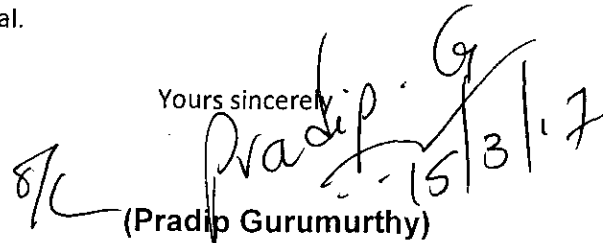
Please refer to your RTI application dated 17.02.2017 under RTI Act, 2005, received in this office on date 23.02.2017.

In this context, point wise required information is as under:-

Point No. (i) - Power to amend provisions of CCS (Pension) Rules 1972 is not vested with Central Excise, Department Nagpur. These powers are vested with the Government. Hence, this office has not initiated any action to amend CCS (Pension) Rules, 1972 and Disciplinary Rules.

Point No. 2(ii) - This office has already informed vide CCOffice, Nagpur Zone, Nagpur vide letter C.No. II(39)24-CON/2005/Part-I dated 31.01.2017 that his appeal is barred by time. (Copy enclosed). Hence no action can be taken on the time barred appeal.
