In this context, point wise required information is as under:-

**Point No. 1 -** The normal duty hours of any Inspector is 09:30 AM to 06:00 PM as per G.I.D.P & A.R,  
OM No. 28034/8/75- ESTT.(A) dated 4<sup>th</sup> July, 1975..

**Point No. 2 -** Yes, The Post of Inspector is bound for 24 hours duty as per the provision of  
Fundamental Rules 11(FR11) old Swamy's book on Fundamental Rules.


**Point No. 3 -** The Central Government Servant is entitled for 08 days Casual Leave in a calendar  
year. At the end of the calendar year i.e 31 December, unutilized Casual leave lapses and not carried  
forward. There is no grant under which accredit of casual leave is allowed. The Casual Leave is  
granted to a Govt. Servant for regularizing his absence of duty for short duration.

**Point No. 4 -** Actual availing the joining time is the actual transit time to report the headquarters.  
In case of transfer at public cost, the transit period will be 12 days in case the headquarters & Range  
office are not connected by Rail, and if these places are connected by rail the maximum time of 10  
days are allowed.

**Point No. 5 -** Suspension are mentioned in Rule 10 of Central Civil Services (Classification, Control  
& Appeal) Rules 1965 [CCS(CCA) Rule 1965]. These provisions are applicable to all officers including  
Inspectors of Central Excise.

**Point No. 6 -** MOT cannot be claim by Superintendent and Inspectors, the amount of MOT  
recovered from the assesses is required to be deposited in to the Government account against which  
OTA can be claimed by Inspector, if his emoluments are below Rs. 2200 per month (Including Special  
Pay & Personal Pay etc.) under FR-9 (21) (a). The Superintendent being Gazetted Officer of  
Government Department is not entitled for OTA.
