In terms of Notification No. 13/2017 - Central Excise(N.T) dtd 09.06.2017 read with Notification No. 17/2017-Central Excise(N.T) dtd 19.06.2017 issued by the Under Secretary, Govt. of India, Ministry of Finance, Department of Revenue, Central Board of Excise and Customs, the existing Nagpur - I, Nagpur-II & Wardha Commissionerates have been re-organised into 2 Central Excise and Service Tax Commissionerates namely Nagpur-I Central Excise and Service Tax Commissionerate, and Nagpur-II Central Excise and Service Tax Commissionerate w.e.f. 22/06/2017.
