Appeals by the Department before CESTAT – Regarding.

In order to reduce the Government litigation, the Monetary limits for filing appeals by the 1. Department before the Hon'ble High Court and the Hon'ble CESTAT have been enhanced vide Instruction F.No.390/Misc./163/2010-JC dated 17/12/2015. Further, these enhanced Monetary limits shall apply to all pending Departmental appeals as clarified vide Instruction F.No.390/Misc./163/2010-JC dated 01/01/2016.

In compliance of these instructions, the Department has filed applications for withdrawal of Departmental appeals pending before the Hon'ble High Court and the Hon'ble CESTAT. The details of these appeals and their present status is as under:
