



1. In terms of Notification No. 2/2017- Central Tax dtd 19/06/2017 issued by the Under Secretary, Govt. of India, Ministry of Finance, Department of Revenue, Central Board of Excise and Customs, the existing Nagpur - I, Nagpur-II & Wardha Commissionerates have been re-organised into 2 Central Tax Commissionerates namely Nagpur-I CENTRAL TAX Commissionerate, and Nagpur-II CENTRAL TAX Commissionerate w.e.f. 22/06/2017.

2. The jurisdiction of CENTRAL TAX Nagpur -II Commissionerate, its Divisions and Ranges shall be as given in Table I and Table II below:-
