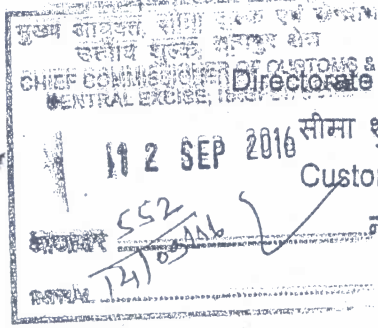

NOTICE FOR CUSTOMS BROKERS EXAMINATION

Applications are invited from Indian citizens to appear in the written examination for issuance of license to act as a Customs Broker under Customs Brokers Licensing Regulations, 2013. A copy of the regulations is available at www.cbec.gov.in and <http://dgicce.nic.in>.

Date of receipt of application: from 03.10.2016 to 18.11.2016

Date and time of Written Examination: 20.01.2017 (10.00 A.M to 1.00 P.M).

Conditions to be fulfilled by the applicants:- As per regulation 5 & 6 of CBLR, 2013.

Syllabus of written examination: As per regulation 6(7) of CBLR, 2013.

Application to be submitted in format: Form-A (available in the notification) along with two passport size photos attested by a gazetted officer (on the front side) & self attested documents on citizenship, educational qualification & financial requirements as per regulation 5 CBLR, 2013 as amended.

Where to submit the application: Principal Commissioner/Commissioner of Customs/Customs (Prev.)/Customs, Cen Ex. & Service Tax having jurisdiction over the area where the applicant intends to carry on his business. [Regulation 4 of CBLR, 2013].

Incomplete applications shall be summarily rejected by 09.12.2016. Information regarding allotted roll numbers & examination venue/ date and time shall be intimated by the concerned Commissionerate. The date of written examination shall not change even if it is declared a holiday. Decision of the Principal Commissioner/Commissioner in this regard shall be final.

The candidates who successfully pass written examination will be called for an oral examination.

The candidates have the option to answer either in Hindi or in English.

In case declarations made by the applicant are found to be incorrect, the application is liable to be rejected and/or license is liable to be cancelled.
